ESTABLISHMENT OF STOCK / SCRAP/ ROOMS AT GWMC WORKSHOP

Interested contractors should provide their Technical and Financial Bids with relevant documents, demonstrating that they have the required qualifications to provide the above-mentioned goods/services. **Single Stage Two Envelope** bidding procedure shall be adopted as per PPRA Rules 2014.

The Estimated Price for the tender is **Rs.875,000/-** The Bid Security for the sum of **PKR 22,000/-** (which is Refundable and within the 5% of the Estimated Value as Per Rule # 27 of PPRA Rules, 2014) in the form of Bank Guarantee/CDR/ Bank Draft/ Pay Order in favor of Gujranwala Waste Management Company, must be submitted with the Bid.

INSTRUCTIONS TO THE BIDDERS

1. The bidder shall seal Financial & Technical Bids, duly signed and stamped, together in one Envelope.
2. The successful bidder shall be required to submit a **Performance Security** in the form of CDR equal to 5% of the value of contract within (10) working days of Letter of Acceptance after which the Purchase/Work Order shall be issued accordingly.
3. The Performance Security shall remain valid for the period of warranty period which is 01 years from the completion of Establishment Of Stock / Scrap/ Rooms At Gwmc Workshop.
4. The Warranty Period shall be **One (01) years** for all the type of works.
5. The prices should be quoted in the local currency i.e. Pak Rupees (PKR), and should be inclusive of all applicable taxes and supply charges.
6. Offers determined to be substantially responsive to the technical specifications will be evaluated by comparison of their prices conformity to required delivery/work completion scheduled. The award will be made to the firm offering the lowest evaluated price and that meets the required standards of technical and financial capabilities.
7. Suppliers duly registered with tax authorities may be eligible to participate only if they also: Submit Proof of registration with the Income Tax Department and Sales Tax Department with the bid. (Failure to enclose these documents would result in rejection of bid)
8. The price bid shall remain valid for the period of thirty (90) calendar days counted from the date of submission of the Bid. The Client may request the Suppliers to extend the period of validity for a specified additional period. The Client's request and the Suppliers' responses shall be made in writing. A Supplier may refuse the request for extension of Bid validity in which case he may withdraw his Bid without any penalty. A Supplier agreeing to the request will not be required or permitted to otherwise modify its Bid.
9. No Bid shall be modified after the deadline for submission of Bid.
10. In evaluating & computing the financial bids, the supplier will be determined by adjusting the price bid by making any correction for any arithmetic errors as follows:
 - (a) Where there is a discrepancy between amounts in figures and in words, the amount in words shall govern;
 - (b) where is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern;
 - (c) If a Client refuses to accept the correction, his Bid will be rejected.
11. The Client reserves the right to accept or reject all bids, and to cancel the process of

competition at any time prior to the award of the Contract, without thereby incurring any liability to the affected Supplier(s).

12. Goods/services must be delivered/completed as per requirement of the client after issuance of Purchase Order/Work Order.
13. The Client, reserves the right to increase or decrease quantities of supplies/services. *(Quantities can be increased or decreased by 15% of its original quantity).*
14. Results of evaluation would be announced as per PPRA Rules, 2014. Suppliers are instructed not to approach the Client after opening of bids until the finalization of award. The Supplier whose Bid has been accepted will be notified of the award by the Client prior to the expiration of the validity period of the Bid, in written. This letter will state the sum that the Client will pay the Supplier in consideration of the supply.
15. The suppliers are requested to give their best and final prices as no negotiations shall take place.
16. Payment(s) shall be made as per the PPRA Rules 2014 in combination with market practice i.e. 100% payment is made on the completion of delivery of goods/services and as per PPRA Rules 2014.

1. Legal Status of the Bidder (Business Individual/Sole Proprietor/Partnership Firm/Company)
2. Proof of valid NTN Registration
3. Proof of valid STRN/PNTN Registration
4. Bank Statement (Certified Bank Statement in the business' name/bidder's name from July 01, 2020 till June 30, 2021)
5. Affidavit/ Undertaking for Correctness of Information, Declaration of non-involvement in litigation / black listing and Compliance to the specifications, conditions and availability of required items on the defined time lines as mentioned in Terms of Reference of this bidding Document (to be provided on non-judicial stamp paper of Rs. 100)

AWARD OF CONTRACT: All bids will be evaluated on basis of above given evaluation criteria and the bidders who do not fulfill above mentioned evaluation criteria will be considered as technically non- responsive bidders and will not be taken into consideration for Financial Evaluation. However technically qualified bidders (Responsive to Evaluation Criteria) will be considered as responsive bidder, and among technically responsive and qualified bidders, the bidder with lowest rates will be awarded the contract (subject to fulfillment of all required conditions of bidding document & PPRA Rules, 2014).
