2. Auction is open to all eligible bidders/ auctioneers/ parties as defined in the eligibility criteria of this auction document
3. Interested eligible bidders may obtain auction documents and further information from the office of GWMC after written submission of application in the name of Chief Executive Officer, GWMC at the cost of Rs. 5000/- (Non-Refundable), which should be deposited in GWMC bank account No: 6580031956800018, Trust Plaza Branch, Bank of Punjab, Gujranwala, during office hours or can be accessed online at, www.gwmc.com.pk.
4. Proposals of only those bidders will be entertained who purchased the auction document & late proposals will be rejected.
5. Interested bidders/ auctioneers/ parties shall submit their rate/ proposal on their letter head & the same shall be sealed in an envelope. The proposals must be delivered to GWMC Head Office on or before closing time i-e 12:00 pm dated 15-01-2024
6. All the proposal will be opened in the presence of bidders/ auctioneers/ parties or their representatives who choose to attend at 12:30 pm in the office of GWMC, on the same date 12:30 pm (with original CNICs of bidders/ representatives)

10. Interested bidders/ auctioneers/ parties shall submit a security deposit in form of CDR/ Pay Order/ Demand Draft in favor of Gujranwala Waste Management Company. Item-wise reserve price & security deposit for the scrap items is as under: -

11. Successful bidder/ auctioneer/ party shall be bound to submit balance amount in ten (10) days from the date of auction. The amount is required to be submitted in the form of CDR/ Pay Order/ Demand Draft in the favor of Gujranwala Waste Management Company.
12. Successful bidder/auctioneer /party will be bound to pay 10% income tax & 16% sales tax and this amount shall be deposited in Government treasury. Proof of payment shall be submitted to GWMC by the successful party.
13. The amount paid by the successful party shall be equal to the quoted unit rate multiplied by the actual quantity/ weight of the scrap. If the actual quantity/ weight comes to be less than the estimation of GWMC, the excess amount shall be returned to the successful party & vice versa
14. Failing to deposit the quoted auction amount by the successful bidder/ auctioneer/ party within prescribed time period may lead to forfeit of its security deposit & legal action may be taken against the participant
15. The proposal submitted without security deposit shall be rejected
16. The bidders/ auctioneers/ parties shall be evaluated on item wise basis and the one with highest rate against the relevant items shall be considered successful
17. If more than one bidder/ auctioneer/ party submit/ quote the same rate of any item, the items shall be equally distributed/ sold to them
18. Successful bidder/ auctioneer/ party is bound to receive all the scrap items from GWMC Workshop and Head Office within 20 days of issuance of permission letter

OR

- b. **For Sole Proprietorship:** Attach Copy of CNIC and an Affidavit/ Undertaking on Non-Judicial E-Stamp Paper of Rs. 500 (sample attached as annexure-A)

OR

- c. **For Partnership Firm/Association of Persons:** Attach Certified copy of Partnership deed and Form C duly issued by Registrar of Firms

2. Registration with Federal Board of Revenue. NTN Certificate to be attached

3. Operational history of at least last three years. Work experience evidence to be attached

4. Statement of the bidders/ auctioneers/ parties bank account duly issued and certified by the bank for a period from Jan 1, 2022 to Dec 31, 2022

5. The bank statement must have an average transaction of minimum Rs 250,000/- per month (credit or debit). A bidder who does not have required average monthly transactions can submit an unutilized credit facility of same amount

6. Proof of general working experience in public or private sector organizations for provision of goods/ services or participation in scrap auction at any time during last 03 years (10 experiences must be attached)
