The Bid Security is as per PPRA Rule # 27 which states that *“The procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price”*. The Bids, without Bid Security, shall be rejected being non-responsive. **(The Original Bid Security must be attached with Technical Bid).**

The bids must be received by **11:30 hours** in the office of GWMC by registered post/courier or delivered in person on or before **26th September, 2019**. The Bids will be opened on the **same date** at **12:00 hours** at the below mentioned address in the presence of bidders or their authorized representatives who choose to attend, with their original CNICs.
