The bid must be accompanied with Bid Security of **Rs.22,000/-** in the form of Bank Guarantee/Demand Draft/CDR/Pay Order, in favor of Gujranwala Waste Management Company. The Bid Security is as per PPRA Rule # 27 which states that “*The procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price*”. The Bids, without Bid Security, shall be rejected being non-responsive.
