Interested Bidders shall provide their Technical and Financial Bids, with required documents, demonstrating that they have the required qualifications, financial soundness and relevant experience to provide the above mentioned items. **'Single Stage Two Envelope'** bidding procedure, shall be adopted as per PPRA Rules, 2014. The bid must be accompanied with Bid Security of **Rs. 128,875/-** in the form of Bank Guarantee/Demand Draft/CDR/Pay Order, in favor of Gujranwala Waste Management Company. The Bid Security is as per PPRA Rule # 27 which states that *"The procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price"*. The Bids, without Bid Security, shall be rejected being non-responsive.
