Interested Bidders shall provide their Technical and Financial Bids, with required documents, demonstrating that they have the required qualifications, financial soundness and relevant experience to provide the above mentioned items. 'Single Stage Two Envelope' bidding procedure, shall be adopted as per PPA Rules, 2014. The bid must be accompanied with Bid Security of **Rs. 132,018/-** in the form of Bank Guarantee/Demand Draft/CDR/Pay Order, in favor of Gujranwala Waste Management Company. The Bid Security is as per PPA Rule # 27 which states that "The procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price". The Bids, without Bid Security, shall be rejected being non-responsive.

The bids must be received by **10:30 hours** in the office of GWMC by registered post/courier or delivered in person on or before **21-04-2022**.
