The bid must be accompanied with Bid Security of **Rs. 90,000** /- in the form of Bank Guarantee/Demand Draft/CDR/Pay Order, in favor of Gujranwala Waste Management Company. The Bid Security is as per PPRA Rule # 27 which states that *"The procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price"*.
