Late bids will be rejected. Bids of only those bidders will be entertained who purchased the tender document.

Interested Bidders shall provide their Technical and Financial Bids, with required documents, demonstrating that they have the required qualifications, financial soundness and relevant experience to provide the above mentioned items. 'Single Stage Two Envelope' bidding procedure, shall be adopted as per PPRA Rules, 2014. The bid must be accompanied with Bid Security of Item# 1 (Rs. 92,470/-) and Bid Security of Item# 2 (Rs. 43,125/-) in the form of Bank Guarantee/Demand Draft/CDR/Pay Order, in favor of Gujranwala Waste Management Company. The Bid Security is as per PPRA Rule # 27 which states that "The procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price". The Bids, without Bid Security, shall be rejected being non-responsive.

The bids must be received by 11:30 hours in the office of GWMC by registered post/courier or delivered in person on or before 20-06-2022.
